EASEMENT TO CONSTRUCT AND MAINTAIN ELECTRIC TRANSMISSION LINE

FOR AND IN CONSIDERATION OF Eighty and no/100 Dollars (\$80.00) in hand paid, the receipt of which is hereby acknowledged, the DEPARTMENT OF CONSERVATION for the STATE OF MICHIGAN does hereby Convey and Quit-Claim to Consumers Power Company a corporation, whose post office address is 212 W. Michigan Ave., Jackson, Michigan and to its successors and assigns, the easement and right to erect and maintain an electric transmission line consisting of poles, structures, wires, cables and conduits, together with anchors, guy wires and other appurtenances and fixtures necessary for the purpose of transmitting and distributing electricity and/or conducting a communication business, together with the right to go upon the land herein described and maintain same on, over and across the following State-owned land:

Land in the Township of Sherman County of Gladwin State of Michigan, as follows, to-wit:

The West one-half (1/2) of the Southwest one-quarter (1/4) of Section eighteen (18), Township twenty (20) North, Range two (2) West.

This easement is granted subject to the following regulations and conditions:

(1) The route to be taken by said line of poles, structures, wires, cables and conduits across, over and under said land being more specifically described as follows: Second party may locate said route on, over and across said above described land along or adjoining as near as practicable a center line, as surveyed, which said center line is described as beginning at a point approximately 1350 feet East of the center line of Trunk Line Highway M-18, so-called, at a point approximately 840 feet North of the East and West quarter line of Section 19, Township 20 North, Range 2 West, running thence Northwesterly to a point approximately 600 feet East of the center line of said highway at a point approximately 30 feet North of the South line of section 18 of said Township, thence Northerly to the East and West quarter line of said Section 18 at a point approximately 600 feet East of the center line of said highway.
