WARRANTY DEED
This Indenture, made January 15, 1969
BETWEEN

and EUGENE ELLSWORTH VAN STEE, a married man, of 3320 Dover Drive, Boulder, Colorado,

parties of the first part.
and CONSUMERS POWER COMPANY, a corporation duly authorized to do business in Michigan and
having its principal office therein at 212 West Michigan Avenue, Jackson, Michigan 49201,

party of the second part.
Witnesseth, That the said party of the first part, for and in consideration of the sum of Two Thousand Five Hundred
and no/100

Dollars (\$2,500.00) to him in hand paid by the said party of the second part, the receipt whereof
is hereby confessed and acknowledged, does by these presents grant, bargain, sell, remise, release, alien and confirm
unto the said party of the second part, its successors and assigns, Forever, all that certain piece or parcel of land situate
and being in the Township of Grant, County of Grand Traverse, and State of
Michigan, and described as follows, to-wit:

A strip of land 330 feet in width across the N 1/2 of the SE 1/4 of
Section 32, T25N, R12W, described as follows: To find the place of
beginning of this description, commence at the Southwest corner of
said section; run thence S 88° 53' 03" E along the South line of
said section 1987.67 feet to the East line of the W 1/2 of the E 1/2
of the SW 1/4 of said section; thence N 01° 04' 47" E along said East
line of the W 1/2 of the E 1/2 of the SW 1/4 of said section 137.19
feet; thence N 50° 13' 10" E, 1829.75 feet to the South 1/8 line of
said section and the place of beginning of this description; thence
continuing N 50° 13' 10" E, 2039.78 feet to a point on the East and
West 1/4 line of said section, which said point is 377.15 feet distant
W'ly of the E 1/4 post of said section as measured along said East and
West 1/4 line of said section; thence N 89° 25' 04" W along said East
and West 1/4 line of said section 509.56 feet; thence S 50° 13' 10" W,
2043.77 feet to the South 1/8 line of said section; thence S 89° 42'
28" E along said South 1/8 line of said section 512.63 feet to the
place of beginning.

Excepting and reserving to first parties the right to construct and
maintain no more than two streets across the land herein conveyed,
each of said streets to be 66 feet wide and to be located in such
places and in such manner that they shall not interfere with the use
of said land by second party.

and to Hold the said premises, as herein described, with the appurtenances, unto the said party of the second part and to its
successors and assigns. Forever. And the said party of the first part, for himself, his heirs, executors and administrators, does
covenant, grant, bargain and agree to and with the said party of the second part, its successors and assigns, that at the time of
the delivery of these presents he is well seized of the above granted premises in fee simple, that they are free from all incum-
brances whatever and that he will, and his heirs, executors, and administrators shall Warrant and Defend the same against all
lawful claims whatsoever.
