Witnesseth, That the said party of the first part, for and in consideration of the sum of ONE DOLLAR and Other Good and Valuable Consideration to him in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, does by these presents grant, bargain, sell, remise, release, alien and confirm unto the said party of the second part, its successors and assigns, Forever, all that certain piece or parcel of land situate and being in the Township Grant, County of Grand Traverse and State of Michigan, and described as follows,

A triangular parcel of land in the SE 1/4 of Section 14, T25N, R12W, described as follows: To find the place of beginning of this description commence at the Southwest corner of said section; run thence S 89° 06' 38" E along the South line of said section 944.31 feet; thence N 37° 08' 20" E, 2858.96 feet to the North and South 1/4 line of said section and the place of beginning of this description; thence continuing N 37° 08' 20" E, 401.83 feet to the East and West 1/4 line of said section; thence N 89° 10' 51" W along said East and West 1/4 line of said section 239.21 feet to the North and South 1/4 line of said section; thence S 00° 36' 17" W along said North and South 1/4 line of said section 323.76 feet to the place of beginning.
