WARRANTY DEED

Witnesseth, That the said party of the first part, for and in consideration of the sum of ONE DOLLAR and Other Good and Valuable Consideration to him in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, does by these presents grant, bargain, sell, remise, release, alien and confirm unto the said party of the second part, its successors and assigns, Forever, all that certain piece or parcel of land situate and being in the Township of Grant, County of Grand Traverse and State of Michigan, and described as follows, to-wit:

A strip of land 330 feet in width across the N 1/2 of the SE 1/4 of Section 1, T25N, R12W, described as follows: To find the place of beginning of this description commence at the S 1/4 post of said section; run thence N 00° 10' 51" E along the North and South 1/4 line of said section 227.06 feet; thence N 34° 22' 03" E, 1298.31 feet to the South 1/8 line of said section and the place of beginning of this description; thence continuing N 34° 22' 03" E, 1570.06 feet to the East and West 1/4 line of said section; thence S 88° 57' 32" E along the said East and West 1/4 line of said section 394.94 feet; thence S 34° 22' 03" W, 1570.04 feet to the South 1/8 line of said section; thence N 88° 57' 37" W along the South 1/8 line of said section 394.95 feet to the place of beginning.

Forever, the easement and right to use a 10 foot wide strip of land situate in the Township of Grant, County of Grand Traverse and State of Michigan, described in Exhibit A and Exhibit B, for the purpose of constructing and maintaining underground telephone lines and equipment under and along said 10 foot wide strip of land, and for no other purposes. The underground telephone lines and other equipment shall be buried a minimum of 3 feet beneath the surface of the ground, said distance being measured vertically from the surface of the ground to the top of said underground lines or equipment and said underground lines shall run along the center line of the 10 foot wide strip of land.

Also, Grantor hereby grants to Grantee Temporary rights for the installation, maintenance and replacement of its underground equipment on the following described land: Two strips of land 15 feet in width lying on each side of the above-captioned 10 foot wide strip of land. Said temporary rights shall cease upon the completion of the installation, maintenance or replacement of Grantee's equipment.
