Ave., Jackson, Michigan, second party, receipt of which is hereby acknowledged, Convey and Warrant to the
second party, its successors and assigns, Forever, the easement and right to erect, lay and maintain lines consist-
ing of ~~poles~~ poles, wires, cables, conduits and other fixtures and appurtenances for the purpose of trans-
mitting and distributing electricity and/or conducting a communication business on, over, under and across the
following described parcel of land, including all public highways upon or adjacent to said parcel of land,
which parcel is situate in the Township of East Bay County of Grand Traverse
Grand Traverse, and State of Michigan, to-wit:

The North fractional $\frac{1}{2}$ of the Southwest fractional $\frac{1}{4}$ of Section 30, Township 27 North, Range 10 West, excepting therefrom that part lying Westerly of the public highway.

The route to be taken by said lines of ~~poles~~ poles, wires, cables and conduits across, over and under said land being more specifically described as follows:

In an Easterly and Westerly direction along or adjoining as near as practicable a center line described as beginning on the North and South $\frac{1}{4}$ line of Section 30, T 27 N, R 10 W, at a point not more than 1350 feet nor less than 1320 feet North of the South line of said Section, running thence Westerly to a point not more than 1150 feet nor less than 1100 feet West of the East line of Section 25, T 27 N, R 11 W, at a point not more than 1350 feet nor less than 1320 feet North of the South line of said Section 25. New line to be not less than 60 feet South of present existing transmission line.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, improving, enlarging and maintaining such cables, conduits and ~~poles~~ poles and other supports, with all necessary braces, guys, anchors, manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction, operation and maintenance of said lines. It is expressly understood that no buildings or other structures will be placed under such wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein authorized.
