

**LICENSE FOR ACCESS AND CONSTRUCTION OF
GROUND GRID**


On this the 1st day of May, 2013, the TRAVERSE CITY LIGHT AND POWER DEPARTMENT, **Grantor**, a Michigan municipal electric utility, whose address is 1131 Hastings Street, Traverse City, Michigan 49686, hereby grants a License to the MICHIGAN ELECTRIC TRANSMISSION COMPANY, LLC, **Grantee**, a Michigan limited liability company, whose address is 27175 Energy Way, Novi, Michigan 48377. This License is granted for access and construction of a ground grid on Grantor's substation property adjacent to a metallic fence around an electric substation and to be located primarily beneath the surface along the common fence line of Grantor's substation property that is adjacent to the Electric Substation Easement given by Grantor to Grantee on August 1, 2012, and recorded at 2012R-16123, Grand Traverse County records.

The area of this License shall be six (6) feet west of the following line:

Commencing in the northwest corner of Section 28, Town 27 North, Range 10 West, East Bay Township, Grand Traverse County, Michigan, thence along the west line of said section S00°47'29" W1335.23 feet to the north 1/8 line of said section; thence along said 1/8 line S88°24'26" E1660.21 feet; thence N00°00'25" E55.25 feet; thence N00°00'25" E54.02 feet; thence N89°59'52" E5.00 feet to the point of beginning; thence N00°00'25" E134.03 feet to the point of ending of said fence line.

The ground grid shall be constructed by Grantee in an area primarily beneath the surface and along and within six (6) feet to the west of said fence line. It shall be constructed according to METC specifications and standards. After construction it shall be the property of Grantor. Grantor shall maintain the ground grid on its property for the duration of the above-described Electric Substation Easement unless otherwise agreed to in writing.


