WARRANTY DEED

This Indenture, made July 22, 1967 BETWEEN JAMES W. MITCHELL, a single man, of Route 2, Rusch Road, Traverse City, Michigan, party of the first part, and CONSUMERS POWER COMPANY, a corporation duly authorized to do business in Michigan and having its principal office therein at 212 West Michigan Avenue, Jackson, Michigan 49201, party of the second part, \$10,000

Witnesseth, That the said party of the first part, for and in consideration of the sum of ONE DOLLAR and Other Good and Valuable Consideration to him in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, does by these presents grant, bargain, sell, remise, release, alien and confirm unto the said party of the second part, its successors and assigns, Forever, all that certain piece or parcel of land situate and being in the Township of Garfield, County of Grand Traverse and State of Michigan, and described as follows, to-wit:

18 GA 495 (1002) A parcel of land in the S 1/2 of the NE 1/4 of Section 35, T27N, R11W, described as follows: To find the place of beginning of this description commence at the Northeast corner of said section; run thence S 00° 02' 52" W along the East line of said section 1318.05 feet to the North 1/8 line of said section and the place of beginning of this description; running thence N 89° 19' 10" W along said North 1/8 line of said section 2633.41 feet to the North and South 1/4 line of said section; thence S 00° 13' 57" W along said North and South 1/4 line of said section 330.01 feet; thence S 89° 19' 10" E, 1441.26 feet; thence N 87° 03' 29" E, 1194.75 feet to the East line of said section; thence N 00° 02' 52" E along said East line of said section 254.53 feet to the place of beginning.

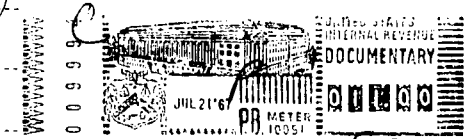
