WITNESSE

It is hereby agreed by and between the parties hereto that selective cutting of standing timber is to be incorporated in connection therewith, also screening will be left where practicable and Grantee agrees to leave small and slow growing underbrush. Timber and brush that is cut is to be placed and piled along the edge of the right of way for natural habitat;

It is further agreed that such line of towers, pole structures, poles, wires, cables and conduits shall be constructed so as to span the bog area located along the route of the easement to minimize disturbance of the wildlife habitat located therein.
