It is hereby agreed by and between the parties hereto that the clearing of trees and brush will be done on a selective bases, but it is understood and agreed that all danger trees may be removed for the reliability of the electric lines.

It is further agreed that no buildings or other structures will be placed within 20 feet on either side of the centerline of the pole structures, poles and wires comprising said electric line.
