Grantor, for good and valuable consideration paid to Grantor by CONSUMERS ENERGY COMPANY, a Michigan corporation, One Energy Plaza, Jackson, Michigan 49201-2276, Grantee, Conveys and Warrants to Grantee, its successors and assigns, Forever, the easement and right to enter at any time and from time to time upon land hereinafter described to cut, trim, remove, destroy, or otherwise control any or all trees and brush now or hereafter standing or growing on said land, said land being in the <u>Township</u> of <u>Acme</u>, County of <u>Grand</u> <u>Traverse</u> and State of Michigan, described as:

The South 150 feet of the West 119 feet of a parcel of land in the Northwest 1/4 of the Northeast 1/4 of Section 6, <u>Township 27 North, Range 9 West</u> described as: Commencing at the North 1/4 corner of Section 6; thence North 89°26'41" East 408.86 feet along the North Section line; thence South 00°14'23" East 52.99 feet to the Southerly right of way line of State Highway M-72 and the point of beginning of this description; thence North 89°41'17" East 166.51 feet along said right of way line; thence South 00°18'43" East 15.00 feet; thence North 89°41'17" East 58.47 feet; thence South 00°14'23" East 659.87 feet; thence South 89°26'41" West 633.86 feet; thence North 00°14'23" West 225.00 feet along the North and South 1/4 line; thence North 89°26'41" East 408.86 feet; thence North 00°14' 23" West 450.83 feet to the point of beginning.

It is expressly agreed that non use or a limited use of the easement and rights hereby granted shall not prevent Grantee from later making use of said easement and rights to the full extent herein authorized. It is further agreed that the consideration received by Grantor for this easement shall be in full payment for the easement and rights hereby granted and for all trees and brush now or hereafter standing or growing on said land.

This easement is exempt from real estate transfer tax pursuant to MCLA 207.505(f) and from State real estate transfer tax pursuant to the provisions of MCLA 207.526(f).
