## PARTIAL ASSIGNMENT OF EASEMENT RIGHTS Towerline Transmission Facilities

THE DETROIT EDISON COMPANY, a Michigan corporation, of 2000 Second Avenue, Detroit, Michigan, (hereinafter called "EDISON") for good and valuable consideration hereby conveys, assigns and quitclaims to International Transmission Company, a Michigan corporation, of 2000 Second Avenue, Detroit, Michigan, (hereinafter called "ITC") its successors and assigns, forever, certain easement rights described in Exhibit A, which is attached hereto and made a part hereof, as well as all right, title and interest of EDISON acquired by occupancy or prescription for rights of way occupied by electric lines operated at 120 kV and higher within Huron County.

It is understood that the towerline easements described herein may accommodate both transmission facilities (120kV or higher) and distribution facilities (less than 120 kV), whether currently built as such or not, and whether currently energized or not. EDISON reserves unto itself, its successors and any future assignees, those distribution rights. Therefore, ITC, as assignee, takes subject to the right of EDISON to utilize these easements for distribution purposes.

Edison covenants and agrees that (I) Edison has the lawful right to transfer said easement rights, and (ii) Edison has not, through its own act or omission, impaired the transferability of said easement rights.

The assignment of said easement rights shall be subject to all interests, agreements and encroachments currently existing on the properties encumbered by the easements described in Exhibit A.

IN WITNESS WHEREOF Edison has caused this instrument to be executed by its duly authorized officer this <u>5th</u> day of <u>PECFUBER</u>, 2000. (Edison shall deliver this Partial Assignment of Easement Rights to ITC on January 1, 2001, at which date it shall be effective).
