IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, WE hereby grant to THE DETROIT EDISON COMPANY its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary H-frames towers, fixtures, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across OUR property located in Grant Township

STREET AND VILLAGE, OR SECTION AND TOWNSHIP
County of Huron, State of Michigan, and described as follows:
The Northwest 1/4 of the Northeast 1/4 of Section 27, T 15 N, R 11 E.

The route of the lines shall be as follows: In a Northeasterly and Southwesterly direction across said land.

In addition to the above consideration, the Company, or its successors and assigns, shall pay US the sum of Fifty and no/100 (\$50.00) - - - - - Dollars for each tower on said land, the same to be paid before any H-frames towers are erected.

AFFIDAVIT OF CONTINUING INTEREST

Matthew S. Carstens, being first duly sworn, deposes and states as follows:

1. This Affidavit of Interest is based upon personal knowledge (or on information and belief, as to matters on which I do not have personal knowledge).
2. I am the Vice President and General Counsel Utility Operations of ITC Holdings Corp., a Michigan corporation, which is the sole owner of International Transmission Company, a Michigan corporation, d/b/a *ITCTransmission* ("ITC").
3. The Detroit Edison Company ("DTE"), a Michigan corporation, and ITC, pursuant to a certain assignment from DTE, are parties to the Tower Line Permits identified on the attached Exhibit A ("Easements").
4. This Affidavit of Interest has been executed and recorded for the purposes of giving record notice of the continuing existence and ITC's intended continuing use of the Easements and the rights of ITC under the Easements.
5. The removal of any poles, towers, crossarms, insulators, wires, guy wires, anchors and other fixtures, structures, cables, or any other equipment for transmitting electricity and affiliated communications, shall in no way be an indication of any intent to abandon the Easements, it being expressly intended by this Affidavit that ITC hereby preserves and reserves its full use and enjoyment of any and all rights in, to or under the Easements.
6. This Affidavit is recorded pursuant to 1915 P.A. 123, as amended.
