Robert E. Minnick and Carol A. Minnick, husband and wife and as Trustees of Minnick Family Trust UAD 11/27/91, 8162 Pleasant Valley Rd., Shepherd, MI 48883 Grantor, for good and valuable consideration paid by CONSUMERS ENERGY COMPANY, a Michigan corporation, 212 West Michigan Avenue, Jackson, Michigan, Grantee, the receipt of which is hereby acknowledged, Conveys and Warrants to Grantee, its successors and assigns, the easement and right to enter upon the land hereinafter described and to construct, maintain, repair, replace and remove a guy stub anchor pole, guy wires and anchor in, over and across said land, which land is in the Township of Coe, County of Isabella and State of Michigan, and described as:

The West 45 feet of the North 200 feet of the South 1170 feet of that part of the West 1/2 of the Northwest 1/4 of Section 21, Township 13 North, Range 3 West lying Easterly of and adjacent to the Easterly right of way line of the Tuscola and Saginaw Bay Railway.

The route to be taken by said guy stub anchor pole, guy wires and anchor in, over and across said land is described as follows:

Beginning at a point not more than 1080 feet nor less than 880 feet East of the West line of Section 21, Township 13 North, Range 3 West at a point not more than 1130 feet nor less than 930 feet North of the East and West 1/4 line of said section; run thence Easterly along and not more than 1080 feet nor less than 880 feet East of the West line of said section to a guy stub anchor pole located at a point not more than 5 feet Southwesterly of the Northeasterly right of way line of the Tuscola and Saginaw Bay Railway and anchor same in the ground not more than 40 feet Easterly of said guy stub anchor pole.

This easement is exempt from real estate transfer tax pursuant to MCLA 207.505(f) and from State real estate transfer tax pursuant to the provisions of MCLA 205.526(f).

Where applicable, pronouns and relative words used herein shall be read as plural, feminine or neuter.
