The Southwest 1/4 of the Northeast 1/4 of Section 28, Township 14 North, Range 3 West.

The route to be taken by said lines of wires, cables and conduits across, over and under said land being more specifically described as follows:

Along a center line described as beginning at a point not more than 1050 ft. nor less than 850 ft. East of the North and South 1/4 line of Section 28, T14N, R3W, at a point not more than 36 ft. South of the East and West 1/4 line of said Section, running thence NE'ly to the North and South 1/4 line of Section 27 of said Township, at a point not more than 400 ft. nor less than 200 ft. North of the East and West 1/4 line of said Section 27. No poles to be set on said land, only lines of wires to overhang said land.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving, enlarging and maintaining such cables, conduits and poles and other supports, with all necessary braces, guys, anchors, manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction, operation and maintenance of said lines.

Second party to pay first party for any damage to crops in erecting and maintaining said line of poles and wires.
