Guy wires to run in a Southerly direction from a pole to be located not more than 500 feet nor less than 400 feet East of the West line of Section 3, Township 16 North, Range 3 West, at a point not more than 43 feet North of the South line of said Section to a guy stub anchor pole to be located in Section 10 of said Township not more than 500 feet nor less than 400 feet East of the West line of said Section 10, at a point not more than 100 feet South of the North line of said Section 10 and anchor same in the ground not more than 50 feet South of said stub pole.

Together with the full right and authority to Grantee, its successors and assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing and maintaining such guy stub anchor pole, guy wires and anchor.

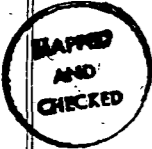
