




DESCRIPTION:

Part of the Southwest 1/4 of the Northwest 1/4 of Section 12, Town 28 North, Range 8 West, Clearwater Township, Kalkaska County, Michigan described as follows:

Commencing at the West 1/4 Corner of Section 12, Town 28 North, Range 8 West; thence South 89 degrees 18 minutes 14 seconds East, along the East-West 1/4 line of Section 12 and the centerline of Plum Valley Road (66 feet wide), 658.04 feet to the **Point of Beginning**; thence North 00 degrees 33 minutes 16 seconds East 1325.59 feet;

thence South 89 degrees 17 minutes 26 seconds East, along the North line of the Southwest 1/4 of the Northwest 1/4 of Section 12, 658.87 feet; thence South 00 degrees 33 minutes 16 seconds West, along the East line of the Southwest 1/4 of
