D. 1917, authorizing, empowering and licensing me, the said Charles A. Schall, Administrator, to sell and dispose of, in conformity to the Statute in such case made and provided, so much of the Real Estate whereof the said Damien Savage, died, seized, for the purpose, as in said Order mentioned, did sell and dispose of, at Private Sale, all of the estates, right, title and interest of said Damien Savage, deceased, in and to certain Real Estate and premises, in said Order set forth and hereafter described, to The Fosco Land Company of Jackson Michigan which said sale was, by an Order made by the said Judge of Probate, on the 24th day of July, A. D. 1917, duly Approved and Confirmed, and I, the said Charles A. Schall, Administrator, by virtue and in pursuance of the said several orders and decrees above referred to, and in consideration of the sum of Eight Hundred Dollars, paid to me, the said Charles A. Schall, Administrator, by the said Fosco Land Company, of Jackson, Mich., the receipt whereof is hereby acknowledged, I have sold and disposed of, and do hereby grant, sell and convey unto the said Fosco Land Company, of Jackson, Mich., its Successors and assigns, FOREVER, all the estate, right, title and interest of the said Damien Savage, deceased, and his said estate, in and to the following described lands, to-wit: The North-east Quarter ( N.E.1/4 ) of the North-west Quarter ( N.W.1/4 ) of Section Twenty-four ( 24 ) Township Nineteen ( 19 ) North of Range Twelve ( 12 ) West, Newkirk Township, Lake County, Michigan, and containing forty acres of land be the same more or less according to the U.S. Survey thereof.
