Only within the Lakehead Easement presently existing in, over or on Lots 18 and 19, Block 12 of Partition Plat of Private Claim No. 1, Section 23, Township 40 North, Range 4 West.

Limited to a 25 volt line, cable, wire cable or conductor and no other.

The route to be taken by said underground cables, conduits, wires and conductors on, in, under, over, through and across said land being more specifically described as follows:

The center line of said underground cables being described as beginning at Edison Sault Electric Company's existing 35 foot service pole located 200 feet, more or less, Northerly of the shoreline of the Straits of Mackinac...

And 24 inches below the surface of the land is now found or later established in the development of the land by the grantor, their heirs, successors or assigns.

Grantor hereby agrees that no buildings... will be placed over said facilities and that no buildings... threaten to interfere with the construction, operation or maintenance of said electrical and/or communication facilities, roads and streets...
