Grantor, in consideration of One Hundred Fifty and No/100 - - - - (\$150.00) - - - - Dollars ( ) to him in hand paid by CONSUMERS POWER COMPANY, a Michigan corporation, 212 West Michigan Avenue, Jackson, Michigan, Grantee, the receipt of which is hereby acknowledged, Conveys and Warrants to Grantee, its successors and assigns, Forever, the easement and right to lay, construct, maintain, repair, remove, patrol, conduits, wires, conductors, and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a communication business in, under, through and across the following described parcel of land, including all public highways upon or adjacent to said land, which land is situate in the Township of Moran, County of Mackinac and State of Michigan, to wit:

Only within the Lakehead Easement presently existing in, over or on Lot 20, Block 12 of Partition Plat of Private Claim No. 1, Section 23, Township 40 North, Range 4 West.

SUBJECT to the following reservations: Reserving to the grantors their heirs, administrators, executors and assigns the right to install within and on the granted easement water lines, sewer lines and also utility lines on the narrow side of said easement within one foot thereof, and to use the surface of the easement for means of travel, ingress and egress to all lands adjoining said easement.

Limited to a 25 volt line cable, wire cable or conductor and no other.

The route to be taken by said underground cables, conduits, wires and conductors on, in, under, over, through and across said land being more specifically described as follows:

The center line of said underground cables being described as beginning at Edison Sault Electric Company's existing 35 foot service pole located 200 feet, more or less, N'ly of the shoreline of the Straits of Mackinac, running thence E'ly to a point approximately 20 feet W'ly of the center line of Lakehead Pipeline Company's existing 20" pipeline, thence N'ly and E'ly along and approximately 20 feet W'ly and N'ly of the center line of said 20" existing pipeline to a certain Michigan Bell Telephone Company's existing pole located E'ly of the W'ly line of Lot 22, Block 12 of Partition Plat of Private Claim No. 1, Section 23, T40N, R4W.

And 24 inches below the surface of the land is now found or later established in the development of the land by the grantors, their heirs, successors or assigns.

Grantor hereby agrees that no buildings will be placed over said facilities and that no buildings will be placed within such proximity to any of said facilities as to interfere with or threaten to interfere with the construction, operation or maintenance of said electrical and/or communication facilities, roads and streets, other than concrete, water lines, sewers, drains of any nature and surface ways of ingress and egress excepted.

When applicable, pronouns and relative words used herein shall be read as plural, feminine or neuter.
