The South one-half (1/2) of the South one-half (1/2) of the Southwest one-quarter (1/4) of Section eleven (11), Township thirty (30) North, Range four (4) East, excepting therefrom the East twenty (20) rods of the North sixteen (16) rods thereof.

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows:

Second party may locate said route on, over and across said above described land along or adjoining as near as practicable a line, which said line is described as beginning at a point not more than 200 feet West of the North and South quarter line of Section 22, Township 30 North, Range 4 East...
