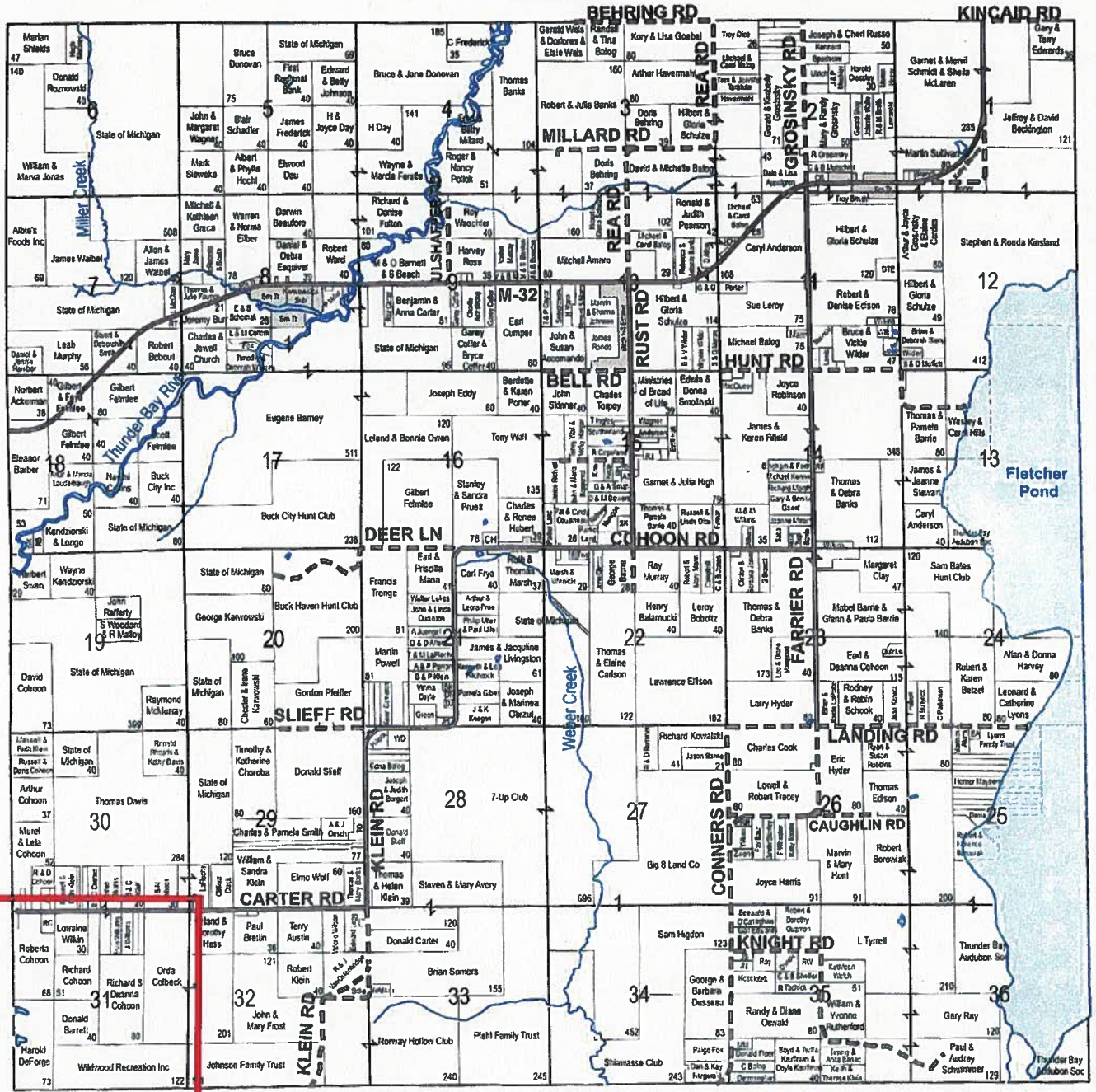
METC received a request from the U.S. Fish and Wildlife Service to build berm in an area where METC has easement rights. Wildwood Club has been working with the U.S. Fish and Wildlife Partners for Fish and Wildlife Service to construct an earthen berm on their property to flood about three acres of bottomlands habitat. The proposed location of the berm is on the power right-of-way that runs through their property, and US Fish and Wildlife are seeking permission from ITC to go ahead with the construction. They received the proper MDNRE permit, and Consumers Power has agreed to let the project continue.

Furthermore, Heather Rwalings (U.S. Fish & Wildlife Service) mentions that the project they are proposing will improve our existing access road, by widening it (12 ft. top width), raising it around four feet, and removing the flooding hazards that currently exist. The existing road and access will remain the same. Access to the towers at the top of both hills will not change. What will change is that they propose to construct a shallow flooding underneath the electrical lines. If needed this area can be temporarily drained by a slight excavation of the spillway. If possible we need to submit a response letter to the by U.S. Fish and Wildlife Service **January 05, 2010.**

Please review and return to my attention with your recommendations/comments.

Dear Mr. Bourgeois,

The grade between the poles goes well below that in the rest of the area. Even the raising of the grade by the dike will not bring it up near to what it is at poles 7477 and 7478. The service road is not directly under the lines; in fact the area under the lines is where the material for the dike would be taken. The pond below the power lines would mean that no trees would be growing that could eventually interfere. The service road is not passable in this area because of washing out. We believe that the dike will be a definite benefit to Consumers by making the service road usable.

Mechanically dredge/excavate 296 cubic yards of sediment. Discharge excavated spoils within an area 45 feet long by 30 feet wide to a height of 5.8 feet for the purpose of creating a dike. Discharge 15 cubic yards of rock riprap within an area measuring 28 feet long by 12 feet wide to a depth of 1 foot to facilitate a spillway. The total project shall create/enhance three acres of wetlands. All work shall be conducted in accordance with the following conditions and attached plans.


Authority granted by this permit is subject to the following limitations:

- A. Initiation of any work on the permitted project confirms the permittee's acceptance and agreement to comply with all terms and conditions of this permit.
- B. The permittee in exercising the authority granted by this permit shall not cause unlawful pollution as defined by Part 31, Floodplain/Water Resources Protection of the NREPA.
- C. This permit shall be kept at the site of the work and available for inspection at all times during the duration of the project or until its date of expiration.
- D. All work shall be completed in accordance with the plans and the specifications submitted with the application and/or plans and specifications attached hereto.
- E. No attempt shall be made by the permittee to forbid the full and free use by the public of public waters at or adjacent to the structure or work approved herein.
- F. It is made a requirement of this permit that the permittee give notice to public utilities in accordance with Act 53 of the Public Act of 1974 and comply with each of the requirements of that act.
- G. This permit does not convey property rights in either real estate or material, nor does it authorize any injury to private property or invasion of public or private rights, nor does it waive the necessity of seeking federal assent, all local permits or complying with other state statutes.
- H. This permit does not prejudice or limit the right of a riparian owner or other person to institute proceedings in any circuit court of this state when necessary to protect his rights.
- I. Permittee shall notify the MDNRE within one week after the completion of the activity authorized by this permit, by completing and forwarding the attached, preaddressed post card to the office addressed thereon.
- J. This permit shall not be assigned or transferred without the written approval of the MDNRE.
- K. Failure to comply with conditions of this permit may subject the permittee to revocation of permit and criminal and/or civil action as cited by the specific State Act, Federal Act and/or Rule under which this permit is granted.
- L. Work to be done under authority of this permit is further subject to the following special instructions and specifications:

1. In issuing this permit, the MDNRE has relied on the information and data that the permittee has provided in connection with the permit application. If, subsequent to the issuance of this permit, such information and data prove to be false, incomplete, or inaccurate, the MDNRE may modify, revoke, or suspend the permit, in whole or in part, in accordance with the new information.
2. The permittee shall indemnify and hold harmless the State of Michigan and its departments, agencies, officials, employees, agents and representatives for any and all claims or causes of action arising from acts or omissions of the permittee, or employees, agents, or representatives of the permittee, undertaken in connection with this permit. This permit shall not be construed as an indemnity by the State of Michigan for the benefit of the permittee or any other person.
3. The authority to conduct the activity as authorized by this permit is granted solely under the provisions of the governing act as identified above. This permit does not convey, provide, or otherwise imply approval of any other governing act, ordinance, or regulation, nor does it waive the permittee's obligation to acquire any local, county, state or federal approval or authorization, necessary to conduct the activity.
4. The property owner and contractor(s) involved in exercising this permit are held responsible to ensure the project is constructed in accordance with all drawings and specifications contained in this permit. The contractor is required to provide a copy of the permit to all subcontractors doing work authorized by this permit.
5. Authority granted by this permit does not waive permit requirements under Part 91, Soil Erosion and Sedimentation Control, of the NREPA, or the need to acquire applicable permits from Montmorency County. Contact Mr. Joe Stone at 989-785-8006.
6. Prior to the initiation of any permitted construction activities, a siltation barrier shall be constructed immediately down gradient of the construction site. Siltation barriers shall be specifically designed to handle the sediment type, load, water depth, and flow conditions of each construction site throughout the anticipated time of construction and unstable site conditions. The siltation barrier shall be maintained in good working order throughout the duration of the project. Upon project completion, the accumulated materials shall be removed and disposed of at an upland (non-wetland, non-floodplain) site. The siltation barrier shall then be removed in its entirety and the area restored to its original configuration and cover.
7. All raw areas resulting from the permitted construction activity shall be promptly and effectively stabilized with sod and/or seed and mulch (or other technology specified by this permit or project plans) in a sufficient quantity and manner to prevent erosion and any potential siltation to surface waters or wetlands.
8. All raw earth within 100 feet of a lake, stream, or wetland that is not brought to final stabilization by the end of the active growing season shall be temporarily stabilized with mulch blankets in accordance with the following dates: September 20th for the Upper Peninsula, October 1st for the Lower Peninsula north of US-10, and October 10th for the Lower Peninsula south of US-10.
9. All fill/backfill shall consist of clean inert material that will not cause siltation nor contain soluble chemicals, organic matter, pollutants, or contaminants. All fill shall be CONTAINED in such a manner so as not to erode into any surface water, floodplain, or wetland. All raw areas associated with the permitted activity shall be STABILIZED with sod and/or seed and mulch, riprap, or other technically effective methods as necessary to prevent erosion.
10. If the project, or any portion of the project, is stopped and lies uncompleted for any length of time other than that encountered in a normal work week, every precaution shall be taken to protect the uncompleted work from erosion, including the placement of temporary gravel bag riprap or other acceptable temporary protection.

11. This permit is limited to authorizing the construction as specified above and carries with it no assurances or implications that associated wetland or floodplain areas can be developed and serviced by the structures authorized by this permit.
12. If any change or deviation from the permitted activity becomes necessary, the permittee shall request, in writing, a revision of the permitted activity and/or mitigation plan from the MDNRE. Such revision requests shall include complete documentation supporting the modification and revised plans detailing the proposed modification. Proposed modifications must be approved, in writing, by the MDNRE prior to being implemented.
13. This permit may be transferred to another person upon written approval of the MDNRE. The permittee must submit a written request to the MDNRE to transfer the permit to the new owner. The new owner must also submit a written request to accept transfer of the permit. The new owner must agree, in writing, to accept all conditions of the permit. A single letter signed by both parties which includes all the above information may be provided to the MDNRE. The MDNRE will review the request and if approved, will provide written notification to the new owner.
14. This permit is being issued for the maximum time allowed under Part 301, Inland Lakes and Streams, and Part 303, Wetlands Protection, of the Natural Resources and Environmental Protection Act, PA 451 of 1994, as amended, including all permit extensions allowed under the administrative rules R 281.813 and R 281.923. Therefore, no extensions of this permit will be granted. Initiation of the construction work authorized by this permit indicates the permittee's acceptance of this condition. The permit, when signed by the MDNRE, will be for a five-year period beginning at the date of issuance.
15. This permit placard shall be kept posted at the work site, in a prominent location at all times for the duration of the project, or until permit expiration.
