

JOINT POLE LINE PERMIT

IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY and the MICHIGAN BELL TELEPHONE COMPANY, their successors and assigns, the right to construct, operate and maintain their lines for the transmission and distribution of electricity and communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across our property located in the Township of Farmington, County of Oakland, State of Michigan, and described as follows:

The North 60 feet of the West 98.5 acres of the Northwest 1/4 of Section 15, Town 1 North, Range 9 East.

The route of the lines shall be as follows: In an Easterly and Westerly direction across said land, approximately 52 feet South of the North line.

The Companies shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

This agreement shall be for the construction of overhead lines only.

Upon 90 days written notice, the Detroit Edison Company shall make such changes and alterations in the said lines as shall be necessary at the time to avoid interference with any improvements or buildings in the course of erection on said land.

In addition to the above consideration, the Companies shall pay us the sum of Five and no/100 (\$5.00) Dollars for each pole on said land, the same to be paid before any poles are erected.
