

RELEASE OF RIGHT OF WAY

For and in consideration of the sum of One Dollar to it in hand paid by AWW Spencer, County Drain Commissioner for the County of Oakland, State of Michigan, receipt of which is hereby acknowledged, The Edison Illuminating Company of Detroit, of 2000 Second Ave., of Detroit, Michigan Township, Oakland County, Michigan, do hereby ~~convey and~~ release to the said County of Oakland, the Right of Way for a certain Drain, to be known and designated as the Big Meadows Drain over and across the following lands owned by The Edison Illuminating Company of Detroit and situated in the Township of Brandon, County of Oakland, and which Right of Way is more particularly described as follows, to wit:

D 338 - A strip of land across part of the N 100 ft of E 1/2 of SE 1/4 of NW 1/4 Sec. 23, Brandon Township, Oakland County, Michigan, the centerline of which is described as follows: Beg at a pt in an existing ditch on the S line of sd parcel said point being dist E 193 ft from the SW corner thereof; th N 2°01' W 100 ft., more or less to the N line of sd described parcel.

The Right of Way hereby ~~conveyed~~ and released is for the sole purpose of locating, establishing and constructing and maintaining over and across said premises, a certain Drain duly designated as the Big Meadows Drain, survey of which is on file in the office of the Drain Commissioner for the County of Oakland, the necessity of which has been determined by the Drain Commissioner of Oakland County, Michigan, as more fully appears from the records in the office of the said Drain Commissioner.

This conveyance shall be deemed to include the extreme width of said Drain and the lands hereinbefore described for use in the construction of said Drain, and includes a release of all claims to damages in any way arising from, or incident to, the opening and maintaining of said Drain across said premises.

On completion of said Drain and acceptance by the Drain Commissioner, it is understood that only 20 feet on both sides of the center line of said Drain as included in this release shall remain in force. All surplus earth to be leveled to grade.
