We IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, **We** hereby grant to **THE DETROIT EDISON COMPANY**, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation, upon, over and across **OUR** property located in

STREET AND VILLAGE, OR SECTION AND TOWNSHIP

County of Oakland, State of Michigan, and described as follows:

A parcel of land in the W. 1/2 of the N.W. 1/4 of Sec. 29 T 1 N, R 11 E. containing 26 acres, more or less, bounded N. by land of Arad Terenyi, E by Barlmont Sub. and Kensington Sub., S. by Northfield Boulevard Sub. and W. by Section line.

The route of the lines shall be as follows:

In an Easterly and Westerly direction across said land in line with Dartmouth Ave. in Sub. East of said land.

Upon thirty (30) days written notice the company shall make such changes in the said lines as shall be necessary at the time to avoid interference with any improvements or buildings in course of erection on said land.

The Company, its successors and assigns, shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property from time to time for the purposes set forth herein.

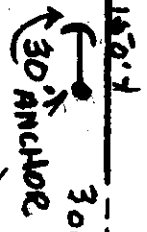
