IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across our property located in CITY OF ROYAL OAK, County of OAKLAND, State of Michigan, and described as follows:

Commencing at the Southwest corner of the Northwest Quarter of Section 5, TlN, RllE, City of Royal Oak, thence North 88°37'30" East along South line of said Northwest Quarter of said section 180 ft., thence North 1°47' West and parallel to the West line of Section 5, 1286.27 ft. to point of beginning, thence North 1°47' West 60 ft., thence North 88°38' East 520.02 ft., thence South 1°31'10" East 60 ft., thence South 88°38' West 519.57 ft. to place of beginning, excepting the West 60 ft. thereof.

The route of the lines shall be as follows: Overhang of wires across said land from the North line thereof at a point approximately 320 ft. East of the West property line to a point on the South line approximately 400 ft. East of the West property line.

The Company shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.
