RIGHT OF WAY FILE NO. 11647

IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across our property located in CITY OF ROYAL OAK, County of OAKLAND, State of Michigan, and described as follows:

Commencing at the SW corner of the NW 1/4 of Sec. 5, T 1 N, R 11 E, City of Royal Oak, Royal Oak Township, thence N 88°37'30" E along S line of said NW 1/4, 180 ft, thence N 1°47' W and parallel to W line of said Sec. 5, 1226.27 ft to place of beginning, thence N 1°47' W 60 ft, thence N 88°38' E 519.57 ft, thence S 1°31'10" E 60 ft, thence S 88°38' W 519.12 ft to place of beginning excepting W 60 ft thereof.

The route of the lines shall be as follows:

Overhang of wires diagonally across said land from the North line thereof at a point approximately 400 ft from West line of said land to a point on the South line approximately 80 ft West of East property line.

The Company shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay us the sum of FIFTEEN AND NO/100 Dollars for said right-of-way across said land, the same to be paid before any lines are erected.
