PARTIAL RELEASE OF EASEMENT

VHEREAS, WARL has succeeded in title to the above described property and has requested a Partial Release of said Easement or Right of Way, and EDISON is willing to grant a Partial Release of its Right of Way, as hereinafter more fully set forth.

NOW, THEREFORE, in consideration of the payment of One (\$1.00) Dollar and other valueble considerations paid by WAHL to EDISON, receipt whereof is hereby acknowledged, EDISON hereby releases and abandons to WAHL that part of the Resement or Right of Way dated October 20, 1948 and recorded on November 23, 1949 in Liber 2500 of Deeds, page 451, Oakland County Records, over land in the City of Royal Oak, Oakland County, State of Michigan, described as follows:

That part of its Easement over the westerly 25 feet of Lots 46 and 49 of Kensington Highlands Subdivision of the Southeast quarter of Section 6, Town 1 North, Range

with the intention of terminating all of the Easement of EDISON over said westerly 25 feet of Lots 48 and 49, and with the intention of reserving, pursuant to the terms of the Easement deted October 20, 1948 and recorded November 23, 1949 in Liber 2500, page 451, Oakland County Records, an Easement over the westerly 25 feet of Lots 42, 43, 44, 45, 46 and 47 of Kensington Bighlands Subdivision of the Southeast quarter of Section 6, Town 1 North, Range 11 East, as recorded in Liber 23, Plats, page 10, Oakland County Records.

In all other respects, except as hereby smended, the Essement or Right of Way deted October 20, 1948 and recorded on November 23, 1949 in Liber 2500, page 451, Cakland County Records, remains in full force and effect.
