IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, We hereby grant to THE DETROIT EDISON COMPANY its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary towers, fixtures, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across our property located in CITY OF ROYAL OAK

STREET AND VILLAGE, OR SECTION AND TOWNSHIP

County of OAKLAND, State of Michigan, and described as follows:

All that certain piece or parcel of land situated in the S.E. Quarter of the N.E. Quarter of Section 8, T 1 N, R 11 E, City and Township of Royal Oak, Oakland County, Michigan, beginning at S.E. corner Lot 223 of Starr Meadows Subdivision, thence N. 0° 17' E. 424.86 ft. to S.W'ly line G.T.R.R. right-of-way, thence S. 28° 53' 30" E. 485.19 ft. along said right-of-way to N'ly line of Webster Road, thence S. 89° 45' W. 232.72 ft. to beginning.

The route of the lines shall be as follows:

Along West of and parallel and adjacent to the right-of-way of the Grand Trunk Western Railroad.

The Company, its successors and assigns, shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.

In addition to the above consideration, the Company, or its successors and assigns, shall pay us the sum of Fifty and 75¢ (50.75) Dollars for each tower on said land, the same to be paid before any towers are erected.
