LOTS 372 AND 373 OF FORDMOUNT PARK SUBDIVISION, A PART OF THE SE 1/4 OF THE SW 1/4, AND PART OF THE W 1/2 OF THE SW 1/4 OF THE SE 1/4 OF SECTION 26, T1N R11E

The route of the lines shall be as follows: IN A NORTHERLY AND SOUTHERLY DIRECTION ACROSS SAID LAND ALONG EAST OF AND ADJALENT TO THE WEST LINE THEREOF.

The Company shall reimburse US for all damage caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.
