The North 125 feet of the West 43 feet of the Northwest 1/4 of the Northeast 1/4 of Section 25, T 1 N, R 11 E.

The route of the lines shall be as follows: In a northerly and southerly direction under and upon said land.

The Company shall reimburse us for all damage caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.
