PARTIAL RELEASE OF RIGHT OF WAY

THIS INDENTURE, made this <u>22nd</u> day of <u>July</u>, A.D. 1957, between THE DETROIT EDISON COMPANY, a New York corporation with its principal office at 2000 Second Avenue, Detroit 26, Michigan, hereinafter celled "EDISON," and IRVIN D. FFIG and SHIRLEY J. FEIG, his wife, of 7777 V. Chicago Avenue, Detroit, Michigan, hereinafter called "OWNER,"

WITNESSFTH:

WHEREAS, on December 28, 1916, FRANK L. ENOWLES granted to THE DETROIT EDISON COMPANY, a New York corporation, the right, privilege and authority to construct, operate and maintain its lines for electric light and power, including the necessary poles, towers, wires and fixtures, upon, over and across property in the Village of Hoyal Oak, County of Oakland and State of Michigan, described as:

WHEREAS, OWNER purports to have succeeded to the title to Lots 34, 35 and 36 of the Subdivision described above; and

WHEREAS, OWNER has requested that EDISON release from the above mentioned Hight of Way grant dated December 28, 1916 that portion of the lands described therein to which they have purportedly succeeded in title.

NOW, THEREFORE, in consideration of One Lollar (\$1.00) and other valuable considerations paid to EDISON by GWNER, receipt whereof is hereby acknowledged, FDISON does by these presents expressly release and abandon unto OWNER all of the rights acquired by it under the aforementioned Right of Way over that portion of the lands covered by said Right of Way which is described as follows:
