IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, the right is hereby granted and conveyed to THE DETROIT EDISON COMPANY, 2000 Second Avenue, Detroit Michigan, and the MICHIGAN BELL TELEPHONE COMPANY, 1365 Cass Avenue, Detroit, Michigan, their licensees, lessees, successors, and assigns, to construct line facilities for the purpose of providing electric service and communication service, including necessary poles, guys, anchors, wires, and equipment, in, upon, over, and across the property located in City of Madison Heights, County of Oakland, State of Michigan, further described as follows: / The North 60 feet and also the Westerly 3 feet of the Northerly 100 feet of the following described property; Commencing at the Northeast corner of Section 1, TIN R11E; thence extending South along the Easterly Section line 285 feet; thence West 235 feet parallel to the Northerly Section line, thence North 285 feet parallel to the Easterly Section line; thence East 235 feet along the Northerly Section line to the point of beginning, with full right of ingress and egress upon the said premises to employes or appointees of the said grantees to construct, reconstruct, repair, operate, and maintain said line facilities, and to trim or cut down any trees which, in the opinion of the grantees, at any time interfere or threaten to interfere with the construction and operation of said line facilities.

The route of the line facilities shall be limited to a line running in an Easterly and Westerly direction across said land, along a line approximately 52 feet South of the centerline of Fourteen Mile Road.
