IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, the undersigned hereby grant to THE DETROIT EDISON COMPANY, a New York corporation, its successors and assigns, the right to construct, operate and maintain an overhead line for street light drop out service over and across strips of land three (3') feet wide, parallel to and adjoining the side lot lines of Lots 204 through ~~290~~<sup>257\* N.A.M. 5-3-63</sup> both inclusive of Capri Villa Sub'n. No. 5, part of the Southeast 1/4 of Section 3, Town 1 North, Range 12 East, City of Warren, Macomb County, Michigan, according to the plat thereof recorded in Liber 51, Page 36 of Plats, Macomb County Records, including also the right to trim or cut down any trees along said line which, in the opinion of THE DETROIT EDISON COMPANY, could fall into the line or interfere in any way with the operation thereof. 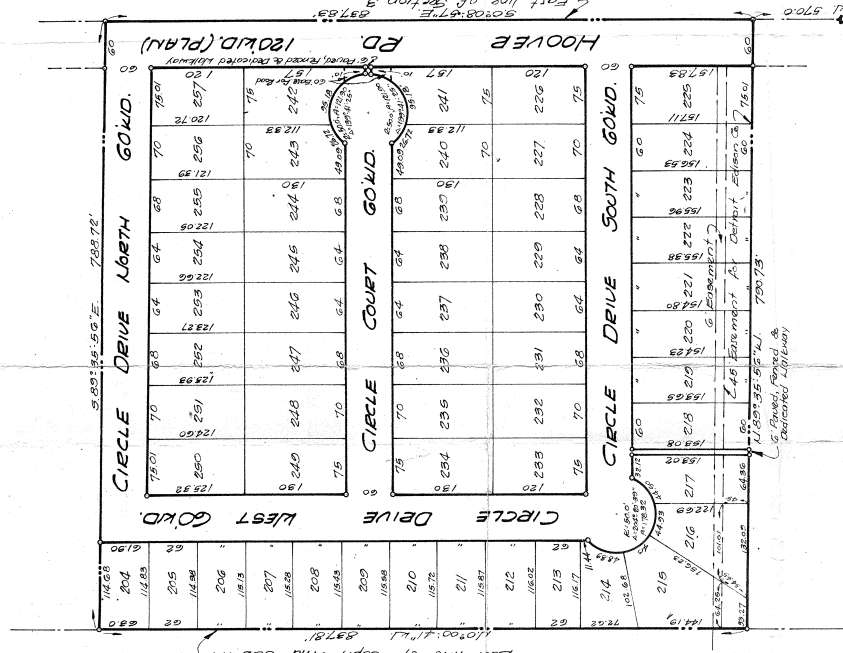
