IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, WE hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their

operation upon, over and across OUR property located in CITY OF SOUTH LYON

County of OAKLAND State of Michigan, and described as follows:

THE EAST 77 FEET OF LOT 15 OF ASSESSOR'S PLAT #5 BEING A PART OF THE SOUTHWEST 1/4 OF SECTION 20 TOWN 1 NORTH RANGE 7 EAST. IN OAKLAND COUNTY RECORDS RECORDED IN LIBER 58 ON PAGE 30.

The route of the lines shall be as follows: ANCHORS ALONG THE WEST LINE AND NOT MORE THAN 60 FEET SOUTH OF THE NORTH LINE AND NOT ~~MORE~~ THAN 6" FROM THE WEST LINE.

The Company shall reimburse NO for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay NO the sum of FIVE 00/100 (\$5.00) Dollars for ABOVE on said land, the same to be paid before any WIRES are erected.
