STREET AND VILLAGE, OR SECTION AND TOWNSHIP

County of Oakland, State of Michigan, and described as follows: Part of the North 1/2 of the Southwest 1/4 of Section 8, Town 1 North, Range 8 East, beginning at a point in the West line of said section South 0°45' West 798.26 feet from the West 1/4 corner of Section 8; thence South 0°45' West along the West line of said Section 8, 209.0 feet to a point; thence South 89°27' East 2718.41 feet to a point in the North and South 1/4 line; thence North 0°32'40" East along the North and South 1/4 line 209.0 feet to a point; thence North 89°27' West 2717.17 feet to the point of beginning.  
The route of the lines shall be as follows: In a northerly and southerly direction across said land along approximately 1240 feet west of the east line thereof.

The Company, its successors and assigns, shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.

In addition to the above consideration, the Company, or its successors and assigns, shall pay us the sum of \_\_\_\_\_ Dollars for each tower on said land, the same to be paid before any towers are erected.

RELEASE OF RIGHT OF WAY

THIS INDENTURE, made this 6th day of December, 1963, between THE DETROIT EDISON COMPANY, a New York corporation, of 2000 Second Avenue, Detroit 26, Michigan, hereinafter referred to as "EDISON" and NICHOLAS PETLICKE and JEAN PETLICKE, his wife, of 34344 Algonquin, Wayne, Michigan, hereinafter referred to as "OWNERS".

WITNESSETH:

WHEREAS, on January 7, 1958 OWNERS granted to EDISON a Right of Way for the purpose of constructing, operating and maintaining its lines for the transmission and distribution of electricity and Company communication facilities upon, over and across premises in the Township of Novi (now City of Wixom), County of Oakland and State of Michigan, described as:

NOW, THEREFORE, EDISON does by these presents expressly release and abandon unto OWNERS all the rights acquired by it by virtue of the aforementioned Right of Way grant dated January 7, 1958.
