IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary towers, fixtures, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across our property located in

Novi Township

STREET AND VILLAGE, OR SECTION AND TOWNSHIP

County of Oakland, State of Michigan, and described as follows:

The west 350 feet of the Northeast 1/4 of the Northwest 1/4 of

Section 20, Town 1 North, Range 8 East.

The route of the lines shall be as follows: In a northerly and southerly direction across said land from a point on the south line approximately 220 feet east of the west line to a point approximately 525 feet due north, thence to a point on the north line approximately 100 feet east of the west line.

The Company, its successors and assigns, shall reimburse US for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.

In addition to the above consideration, the Company or its successors and assigns, shall pay us the sum of Four Hundred and no/00 (\$400.00) Dollars for each tower on said land, the same to be paid before any towers are erected.
