RELEASE OF RIGHT OF WAY

THIS INDENTURE, made this 30th day of October, 1964, between THE DETROIT EDISON COMPANY, a New York corporation, of 2000 Second Avenue, Detroit 26, Michigan, hereinafter referred to as "EDISON", and WILLIAM J. ALLAN, a married man, of 5768 14th Street, Detroit 8, Michigan, hereinafter referred to as "OWNER".

W I T N E S S E T H:

WHEREAS, on July 14, 1956, William J. Allan and Celia L. Allan, his wife, granted to EDISON a Right of Way for the purpose of constructing, operating and maintaining its lines for the transmission and distribution of electricity and Company communication facilities upon, over and across premises in the Township of Novi, Oakland County, Michigan, described as follows:

The West 200 feet of that part of the East 1/2 of the Northwest 1/4 of Section 17, Town 1 North, Range 8 East, lying North of Grand River Avenue (US-16).

which Right of Way is recorded in Liber 3567, Page 238, Oakland County Records; and

WHEREAS, OWNER purports to have succeeded to the title to the above described property; and

WHEREAS, OWNER has requested that EDISON release the above mentioned Right of Way Grant and EDISON is willing to do so.

NOW, THEREFORE, EDISON does by these presents expressly release and abandon unto OWNER all the rights acquired by it by virtue of the aforementioned Right of Way Grant dated July 14, 1956.
