

IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, I hereby grant to THE DETROIT EDISON COMPANY its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary towers, fixtures, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across my property located in Novi Township.

STREET AND VILLAGE, OR SECTION AND TOWNSHIP
County of Oakland, State of Michigan, and described as follows:

The west 1/2 of the west 1/2 of the east 1/2 of the northwest 1/4 of Section 8, Town 1 North, Range 8 East excepting therefrom that part included in highway.

The route of the lines shall be as follows: In a northerly and a southerly direction across said land along approximately 100 feet east of the west line.

This agreement also includes the right to clear and keep clear of trees a strip of land 200 feet wide being 190 feet on each side of centerline of the towerline.

The Company, its successors and assigns, shall reimburse me for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.

In addition to the above consideration, the Company, or its successors and assigns, shall pay the sum of four hundred and no/100 (400.00) Dollars for each tower on said land, the same to be paid before any towers are erected.

RELEASE OF RIGHT OF WAY

offices at 2000 Second Avenue, Detroit, Michigan 48226, hereinafter referred
to as "EDISON", and RAY THEODORE COLEMAN, also known as, VERN T. COLLINS
of 48881 West Road, Wixom, Michigan, hereinafter referred to as "OWNER".

W I T N E S S E T H :

WHEREAS, on June 2, 1956, Ray Theodore Coleman, granted to EDISON
a right of way for the purpose of constructing, operating and maintaining
its lines for the transmission and distribution of electricity over, upon
and across premises in Novi Township, Oakland County, Michigan, described as
follows:
