PARTIAL RELEASE OF RIGHT OF WAY

between THE DETROIT EDISON COMPANY, a corporation organized and existing concurrently under the laws of the states of Michigan and New York, of 2000 Second Avenue, Detroit, Michigan 48226, hereinafter referred to as "EDISON", and THADDEUS S. PUTT and BERTHA L. PUTT of 27047 Wixom, Novi, Michigan, hereinafter referred to as "OWNERS", being land contract purchasers from Triangle Associates, a Michigan Co-Partnership of 21751 West Eleven Mile Road,

WITHESSETH:

WHEREAS, on October 17, 1955, Ernest G. Lowery and Ann C. Lowery, his wife, granted to EDISON a Right of Way for the purpose of constructing, operating and maintaining its lines for the transmission and distribution of electricity and Company communication facilities over, upon, and across premises in Novi Township, Oakland County, Michigan, described as fellows:

The East 350 feet of the South 1/4 of the Northeast 1/4 of Section 18, Town 1 North, Range 8 East, except the South 491.30 feet thereof.

which Right of Way is recorded in Liber 3514, Page 123, Oakland County Records, and WHERRAS, OWNERS purport to be purchasing the above described property

WHEREAS, OWNERS have requested that EDISON release the abovementioned grant.

on land contract from Triangle Associates, and

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, EDISON does, by these presents and subject to the conditions hereinafter stated, release, quit claim and abandon unto OWNERS, their heirs, successors and assigns, all of the rights acquired by them, except as stated below, under the aforementioned Right of Way Grant as it may pertain to that part of the lands described in said grant, to which OWNERS purport to have succeeded to title. Excepted from this release is that portion of a strip of land approximately twelve (12') feet wide, over, upon, and across the premises described as six (6') feet on either side of the northerly

A line running in a northerly and southerly direction across the Northeast 1/4 of Section 18; Town 1 North, Range 8 East; City of Novi, Oakland County, described as: Beginning at a point on the North line of Section 18, 53.3 feet westerly from the Northeast Corner of said Section 18; thence in a southerly direction 1678.8 feet to a point that is 53.0 feet from the East line of said Section 18, measured at right angles to said East line; thence on a line making a morthwesterly angle of 88°48'30" with the last described line 248.5 feet to a point; thence southerly on a line making a southeasterly angle of 89°09'20" with the last described line to a point on the East and West 1/4 line of said Section 18, 301.0 feet westerly from the East 1/4 Corner of said Section 18.

Metwithstanding the terms and conditions contained in the aforementioned Right of Way Grant, this release is granted to, and receipt thereof is acknowledged by the GWEERS upon the express condition that no buildings or structures shall be placed within the premises which are excepted from this release, being that portion of said strip of land twelve (12') feet wide, as described above, without the prior written consent of EDISCH. Furthermore, EDISCH shall have the right to trim or cut down any trees within that portion of said strip of land twelve (12') feet wide, which it deems could fall into its lines or interfere with the operation and maintenance thereof.

Subject to the conditions herein contained in all respects, except as to the extent hereby released, the aforementioned Right of Way Grant dated October 17, 1955, shall and do remain in full force and effect.
