IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged,

~~WE~~ hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their

operation upon, over and across OUR property located in Novi Township

County of Oakland State of Michigan, and described as follows: The East 60 ft of that part of the East 1/2 of

the SE 1/4 of Section 7, T1N R8E lying South of US 16 Hwy. Also a parcel beginning at the NE 1/4  
corner of Section 18, T1N R8E, thence S on E line of said section 1682.6 ft, thence W parallel to  
the E and W section line 302.5 ft, thence S parallel to the N and S section line 297.4 ft to the  
S property line, thence W parallel to the E and W section line 60 ft, thence N 360 ft parallel to  
the N and S section line, thence E 242.5 ft to a point, thence N parallel to the N and S line to  
the N line of said section, thence E on N line of said section to point of beginning.

The route of the lines shall be as follows: In a Northerly and Southerly direction across the North  
1682 feet of said land, along approximately 52 feet West of the East line, thence Westerly  
approximately 320.5 feet, thence Southerly approximately 297.5 feet to the South line thereof.

Upon 90 days written notice the company shall make such changes and alterations in the said lines  
as shall be necessary at the time to avoid interference with any improvements on buildings in  
course of erection on said property.

The Company shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay us the sum of Five and no/100 (\$5.00) Dollars for each pole on said land, the same to be paid before any poles are erected.
