IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, WE hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across 014 property located in NOVI TOWNSHIP

County of OAKLAND State of Michigan, and described as follows:

A PART OF THE EAST 1/2 OF THE SOUTH EAST 1/4 OF SECTION 7 TOWN 1 NORTH RANGE 8 EAST Beg. at a point on the EAST SECTION LINE DIST NORTH 1°20'16"W 448.40 FT. FROM SOUTHEAST CORNER, TH N 72°46'16"W 282.39 FT, TH N 1°20'16"W 71.18 FT, TH N 88°39'44"E 267.69 FT, TH S 1°20'16"E 161.09 FT ALONG EAST SECTION LINE TO beg.

The route of the lines shall be as follows:

THE ROUTE OF THE LINES SHALL BE AS FOLLOWS. IN A NORTHERLY AND SOUTHERLY DIRECTION, ACROSS SAID LAND, ALONG APPROXIMATELY 92 FEET WEST OF THE EAST PROPERTY LINE THEREOF
NOTE: ONE POLE ONLY ON PROPERTY

The Company shall reimburse NO for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay NO the sum of FIVE & 7/100 (\$5.00) Dollars for each pole on said land, the same to be paid before any poles are erected.

RIGHT OF WAY PERMIT FOR MICHIGAN BELL TELEPHONE COMPANY
