WE IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wire and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across OUR property located in NOVI TOWNSHIP

County of OAKLAND State of Michigan, and described as follows:

THE NORTH 10 FEET OF THE WEST 150 FEET OF THAT PART OF THE SOUTH 1/2 OF THE SOUTHWEST 1/4 OF SECTION 8 TOWN 1 NORTH RANGE 8 EAST Desc. AS BEGINNING AT A POINT DISTANT N. 0° 06' W 575.87 FEET FROM THE SW SECTION CORNER, thence 0° 06' W 250 FT, thence N 89° 45' E 872.65 FT, thence S 0° 10' E 250 FT, thence S 89° 45' W 873.04 FT. TO BEG.

The route of the lines shall be as follows: ANCHORS IN AN EAST AND WESTLY DIRECTION, ACROSS SAID LAND ALONG AND ADJACENT TO THE NORTH LINE THEREOF

The Company shall reimburse US for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

Above In addition to the above consideration, the Company shall pay US the sum of FIVE & 10/100 (\$5.00) Dollars for on said land, the same to be paid before any WIRES are erected. RIGHT OF WAY.
