IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY and the MICHIGAN BELL TELEPHONE COMPANY, their successors, licensees and assigns, the right to construct, operate and maintain their lines for the transmission and distribution of electricity and for communication services, including the necessary poles, fixtures, guys, enchors, guy stubs, wires and equipment installed upon or to be installed upon, in, over and across our property, and including also the right to trim or cut down any trees along said lines which could fall into the lines or interfere in any way with their operation. Said property is located in the Village of Novi, Oakland County, Michigan, and is described as:

An easement six (6') feet in width with its centerline described as follows:

Beginning at a point in the East line of Sixthgate Avenue 153.48 feet distant southerly from the southerly line of Grand River Road, thence southeasterly to a point in the west line of Coachenfour Drive, 153.69 feet southerly of the south line of Grand River Road. Said centerline being also described as three (3') feet southerly of the rear lot lines of Lots 1 through 10 of "Novi Gardens Sub" of part of the northwest 1/4 of Section 23, Town 1 North, Range 8 East, Novi Township, according to the plat thereof recorded in Liber 60, Page 18 of Plats, Oakland County Records.

We further agree that no buildings or structures, except necessary line fences, are to be erected within the limits of the above described easement.
