In Consideration of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant permission to **The Detroit Edison Company**, its successors and assigns, to construct, operate and maintain during its corporate life, its lines for electric light and power, including the necessary towers, fixtures, wires and equipment; and including also the right to trim any trees along said lines, so as to keep the wires clear by at least twelve (12) feet, upon, over and across our property located in Novi Township

County of Oakland State of Michigan, and described as follows: That part of the northwest one-quarter (1/4) of Section Five (5) bounded on the north by the Village of Wilson and Pere Marquette Railroad, on the east by Pere Marquette Railroad and land of Farman, on the south by lands of Farman and Kitson and on the west by land of Kitson and the west line of Section Five (5).

The route of the lines shall be as follows: In a northeasterly and southwesterly direction as staked across said land.

The Company shall reimburse no for all damage to growing crops, buildings or fences, caused by its men and teams and trucks in entering said property for the purposes set forth herein.

In addition to the above consideration, the Company shall pay no the sum of fifteen (15.00) Dollars in fence and forty five (45.00) Dollars in field Dollars for each tower on said land, the same to be paid before any towers are erected.
