

IN CONSIDERATION of advantages to accrue to me or because it is best choice, the right is hereby granted to THE DETROIT EDISON COMPANY its successors and assigns, to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment and including the right to trim or cut down any trees along said lines which might in the opinion of THE DETROIT EDISON COMPANY or its successors and assigns, in any way interfere with or be hazardous to the construction, operation and maintenance of said lines, upon, over and across own property in the City of Farmington County of Oakland State of Michigan, further described as follows:

Part of Southeast 1/4 beginning at a point on centerline of U.S. 16 Highway which is located N. 0° 03' 30" East on East Section line 263.03 Feet and N. 58° 23' West along said centerline 387.75 Feet from Southeast corner of Section 27, thence on a curve to right angle said centerline with Rad. of 41,000 Feet and chord beginning N. 58° 03' West 211.5 Feet, thence north 5.7053' West along said centerline 153.35 Feet to southeast corner of Brookdale Subdivision, thence N. 0° 01' East along East line of said Subdivision 1,226 Feet, thence South 47° East 338.18 Feet, thence North 0° 06' West 517.3 Feet to centerline of Shiawassee Road, thence South 61° 18' East along said centerline 33.32 Feet, thence South 0° 06' East 1,793.14 Feet to beginning, except (over)

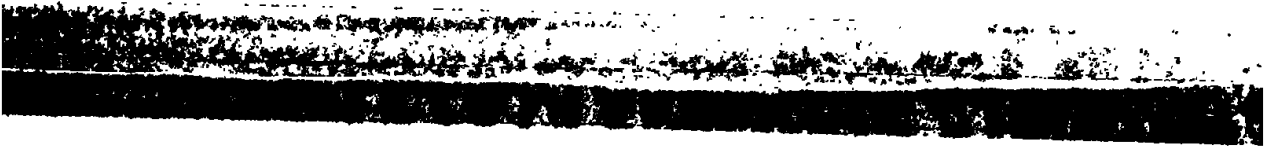
