County of OAKLAND State of Michigan, and described as follows: THE EAST 1/2 OF LOT 64 OF FARMINGTON ACRES SUBDIVISION OF THE SOUTH PART OF THE SOUTHWEST 1/4 OF SECTION 33 TOWN 1 NORTH RANGE 9 EAST AS RECORDED IN LIBER 21 ON PAGE 10 OF OAKLAND COUNTY RECORDS.

The route of the lines shall be as follows: E-N AN EASTERLY AND WESTERLY DIRECTION, ALONG AND ADJACENT TO THE SOUTH LINE THEREOF

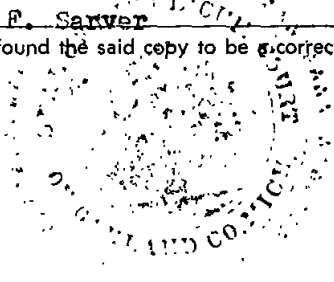
