IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its underground lines for the transmission and distribution of electricity and Company communication facilities, including the necessary conduits, fixtures, cables, manholes and equipment, under and across our property located in the City of Farmington, County of Oakland, State of Michigan, and described as follows:

A strip of land 14 feet wide, the centerline of which commences at a point on the East line of Section 27, Town 1 North, Range 9 East, which point is 296 feet southerly of the intersection of the East line of said Section 27 and the South line of Shiawassee Road (60 feet wide); thence westerly at right angles to said East section line, a distance of 36 feet; thence northerly at right angles to the last described line along a line parallel to said East section line to the South line of Shiawassee Road.

The Company shall reimburse us for all damage caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purposes set forth herein.
