For good and valuable consideration of system betterment, the undersigned hereby grant and convey to THE DETROIT EDISON COMPANY, a Michigan corporation of 2000 Second Avenue, Detroit, Michigan, hereinafter referred to as "EDISON," the right to construct, reconstruct, modify, add to, operate and maintain overhead line facilities consisting of poles, guys, anchors, wires, cables, transformers and accessories required to provide electric services in, upon, over and across property located in the **City of Farmington Hills**, **County of Oakland** State of Michigan, further described as follows:

All of Lots 4, 5, 6 and 7 and part of Lot 8 of "Maple Lane Subdivision", as recorded in Liber 73, Page 9 of Plats, Oakland County, Michigan Records and a part of the Northwest 1/4 of Section 16, T1N, R9E, City of Farmington Hills, Oakland County, Michigan, more particularly described as: Commencing at the North 1/4 corner of Section 16, thence South 87°53'28" West 438.54 ft. along the North line of said Section, thence South 02°23'23" East 90.00 ft. to the point of beginning on the Southerly right-of-way line of Twelve Mile Road, thence South02°23'23" East, 1010.00 ft., thence South 87°53'28" West 420.00 ft., thence South 02°23'23" East 169.36 ft. to the Northerly line of Interstate 696, thence South 85°28'16" West 911.24 ft. along said line, thence North02°06'32" West, 717.02 ft., thence North 47°06'32" West 166.01 ft., thence North 02°14'32" West, 413.41 ft. to the Southerly line of Twelve Mile Road, thence along said line the following three courses: (1) North 87°53'28" East, 872.85 ft., and (2) South 02°23'23" East, 30.00 ft., and (3) North 87°53'28" East 570.00 ft. to the point of beginning.

The route of the line facilities is described as follows: Two (2) 3ft. X 20 ft. anchor slots as shown on the attached Detroit Edison drawing Ø-9698 dated 11/15/89 which is made a part hereof.

The right of way is three (3) feet in width.

The rights hereby granted include the right of access to and from the right of way and the right to trim, cut down or otherwise control brush and trees either within the right of way or on property adjoining the right of way which in the opinion of EDISON interferes with the construction or operation of the line facilities. It is expressly understood and agreed that EDISON shall, at no time, trim or cut down any trees unless, in EDISON'S opinion, it is absolutely necessary to do so. EDISON shall restore premises to its original condition or as near as can be in the event of damages caused by its employes, contractors, vehicles and equipment entering premises for the purposes set forth herein. No buildings or structures are to be placed within said right of way herein granted without the written consent of the GRANTEE. This grant is deciared to be binding upon the heirs, successors, lessees, licensees and assigns of the parties hereto.


