Lot 51 of the Heights, a replat of lots 421 to 508 inclusive and lots 693 to 701 inclusive of Quanton Lake Estates, a part of the Northeast quarter of Section 26, Town 2 North, Range 10 East, Bloomfield Township.

The route of the lines shall be as follows: Under the Northeast corner of said lot as now existing and shown on attached Detroit Edison Company sketch #U3-2-4469

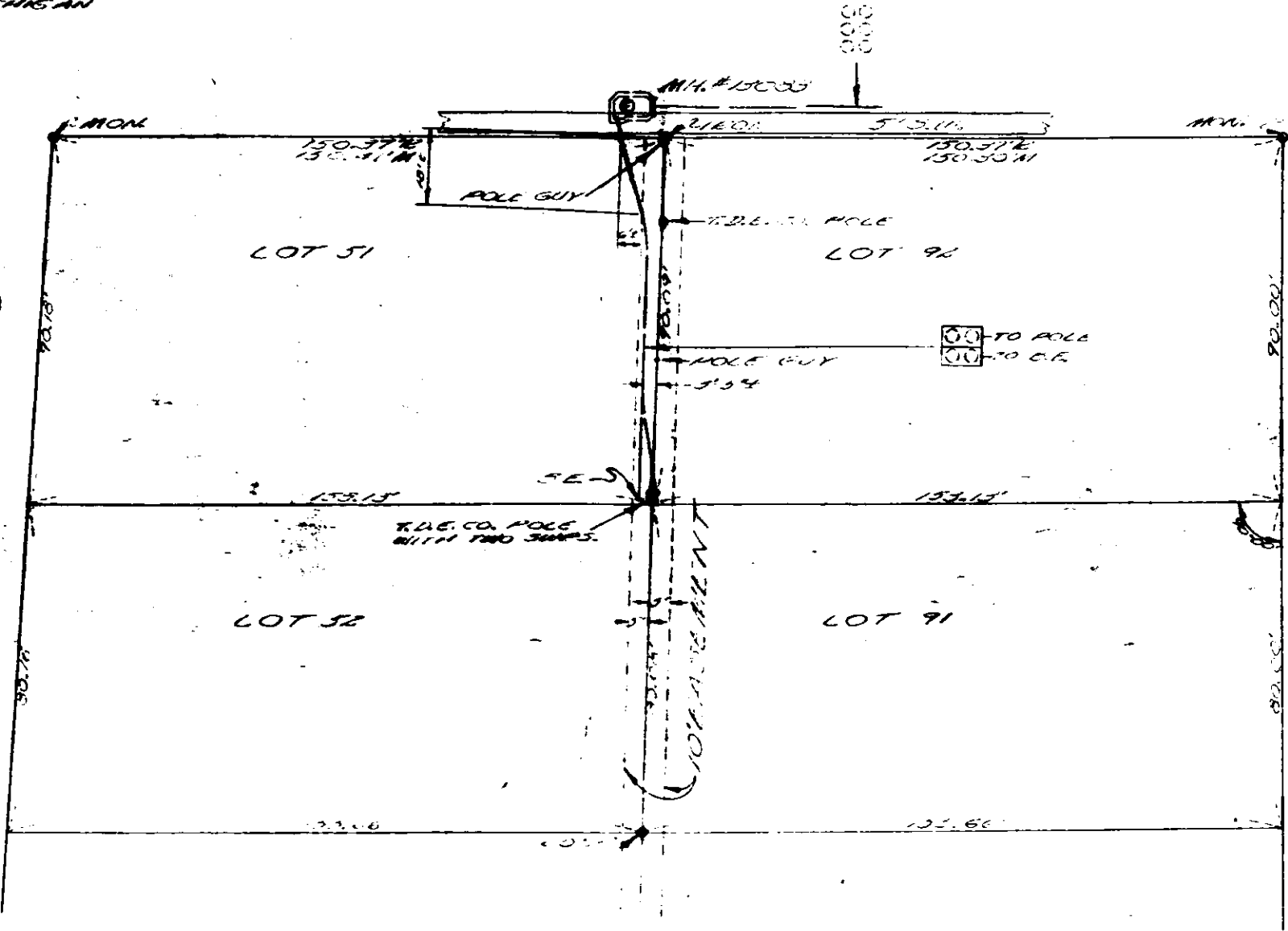
