THIS AGREEMENT made this 30th day of October A.D., 1959,
by and between TROWBRIDGE FARMS COMPANY, a Michigan corporation, party of the
first part, THE DETROIT EDISON COMPANY, a New York corporation, and MICHIGAN
BELL TELEPHONE COMPANY, a Michigan corporation, parties of the second part and
LEWIS E. BURGESS and ROSEMARY E. BURGESS, his wife, parties of the third part,
WITNESSETH AS FOLLOWS:

WHEREAS, the party of the first part holds title to Lots 67 and
68, Trowbridge Farms No. 1, a resubdivision of part of Lot 39 and all of Lots 40
and 41 of "Trowbridge Farms" Subdivision, and a subdivision of part of the North-
east Quarter (NE $\frac{1}{4}$) of Section 23, Town 2 North, Range 10 East, City of Bloomfield
Hills, Oakland County, Michigan, as recorded in Liber 86 on Page 18 of Plats,
Oakland County Register of Deeds office, and

WHEREAS, certain easements were granted by the first party hereto,
to the second parties hereto, for their public utility purposes by an Agreement
dated February 24, 1958, and recorded in Liber 3816, Pages 488 to 492 inclusive,
Oakland County Records, which Agreement the said second parties now desire to
amend, and

WHEREAS, parties of the third part hereto, now have an interest in
said Lot 68, Trowbridge Farms No. 1, having purchased from the party of the first
part hereto under a land contract.

NOW THEREFORE, in consideration of the premises, and each in con-
sideration of the undertakings of the others hereinafter set forth, the parties
hereto hereby agree that the description appearing on the third page of said
Agreement as lines 14 to 18 inclusive shall be amended to read as follows:

"Beginning at the northwest corner of Lot 67, said
Trowbridge Farms No. 1; thence easterly to a point
in the easterly side lot line of said lot, which
point is distant 25 feet southerly along said side
lot line from the northwest corner of said lot; thence
easterly to the northeast corner of Lot 68 said Sub-
division."
